Gideon's Promise is one of the nation's leading public defender education programs. It uses a comprehensive, interactive curriculum to prepare new public defenders to raise the standard of representation in challenging environments. The program teaches values, substantive knowledge, skills essential to being a public defender, and helps its lawyers develop strategies for implementing these lessons in the courthouses where they work.

The Trainer Development Conference (TDC) teaches cutting edge techniques for legal professionals who educate existing or future lawyers who represent poor people accused of crimes. TDC is only offered to members of the public defender community. It is open to public defender trainers and clinical professors who teach exclusively in criminal defense clinics.

The effectiveness of Gideon's Promise training is evidenced by its support from leading foundations such as the Open Society Foundation, Ford Foundation, and the United States Department of Justice. In 2014, Gideon's Promise Founder Jonathan Rapping was awarded with the prestigious MacArthur 'Genius' Grant. Gideon's Promise has partnered with over 45 offices to provide training to young public defenders across 17 states.



## **Track 1**

### **Curriculum Development**

### **2 Days**

Track 1 introduces participants to the Gideon's Promise Summer Institute core curriculum. This core curriculum maintains six key values including building community and inspiring public defender pride, reinforcing client-centered values, developing pretrial and trial skills, and helping participants learn effective storytelling and persuasion techniques. Track 1 trains attendees in how Gideon's Promise infuses these values into skill-building sessions.

Participants will learn about over twenty learning sessions and workshops and how each fits into the larger programmatic vision of Gideon's Promise. This track will teach participants the techniques used to reinforce these lessons through workshops and exercises.

## Track 2 Facilitation & Coaching 3 Days



Track 2 focuses on advanced training and mentoring skills that build on the lessons taught in Track 1. Using parts of the Gideon's Promise training curriculum, participants will focus more deeply on teaching methodology.

In this track, the sessions will consist of small workshop groups where participants will develop their training skills through role-playing and learning exercises. Training attendees will learn how to provide feedback to their own trainees, will work through teaching hypotheticals, and will be exposed to the Gideon's Promise model of "Closing the Gap," that is a pedagogical tool to help maintain client-centered values in difficult circumstances.

Participation in Track 1 is required before participating in Track 2. Many Trainer Development Conference attendees stay for the full five days to complete tracks 1 and 2.
