### WHAT MAKES PRACTICING IN YOUR JURISDICTION UNIQUELY CHALLENGING?

Due to the significant population growth and low housing options, those with felony records have a hard time finding suitable housing. Possession by ingestion is felony and the maximum penalty is 10 years in prison. People can travel to Colorado to legal purchase marijuana and other items containing THC but Delta -9 in SD is a Class 4 felony. I 90 and I 29 traps many unwary citizens of the consequences of traveling with such items.

### POPULAR ATTRACTIONS FOR ATTORNEYS TO VISIT WHILE IN YOUR CITY:

Sioux Falls is the largest city in South Dakota and was recently said to be the 47th quickest developing city in the country. Probably the best known attraction is Falls Park, established around the city's namesake, which are the waterfalls on the Big Sioux River, just north of downtown. Sioux Falls also has a large variety of attractions from the Great Plains Zoo, Sertoma Butterfly House & Marine Cove, as well as a variety of breweries and places to dine in the downtown area.
