Entering private practice, Richard handled his first death eligible case in 1993. Richard has been a member of the faculty at the Santa Clara School of Law Death Penalty College since 2008. He is also a member of the Faculty at the National College for Capital Voir Dire in Boulder, Colorado since 2014. In 2019, Richard was awarded the Honorable Robert Lewis Cohen Award for Professional Excellence by the New York Criminal Bar Association.

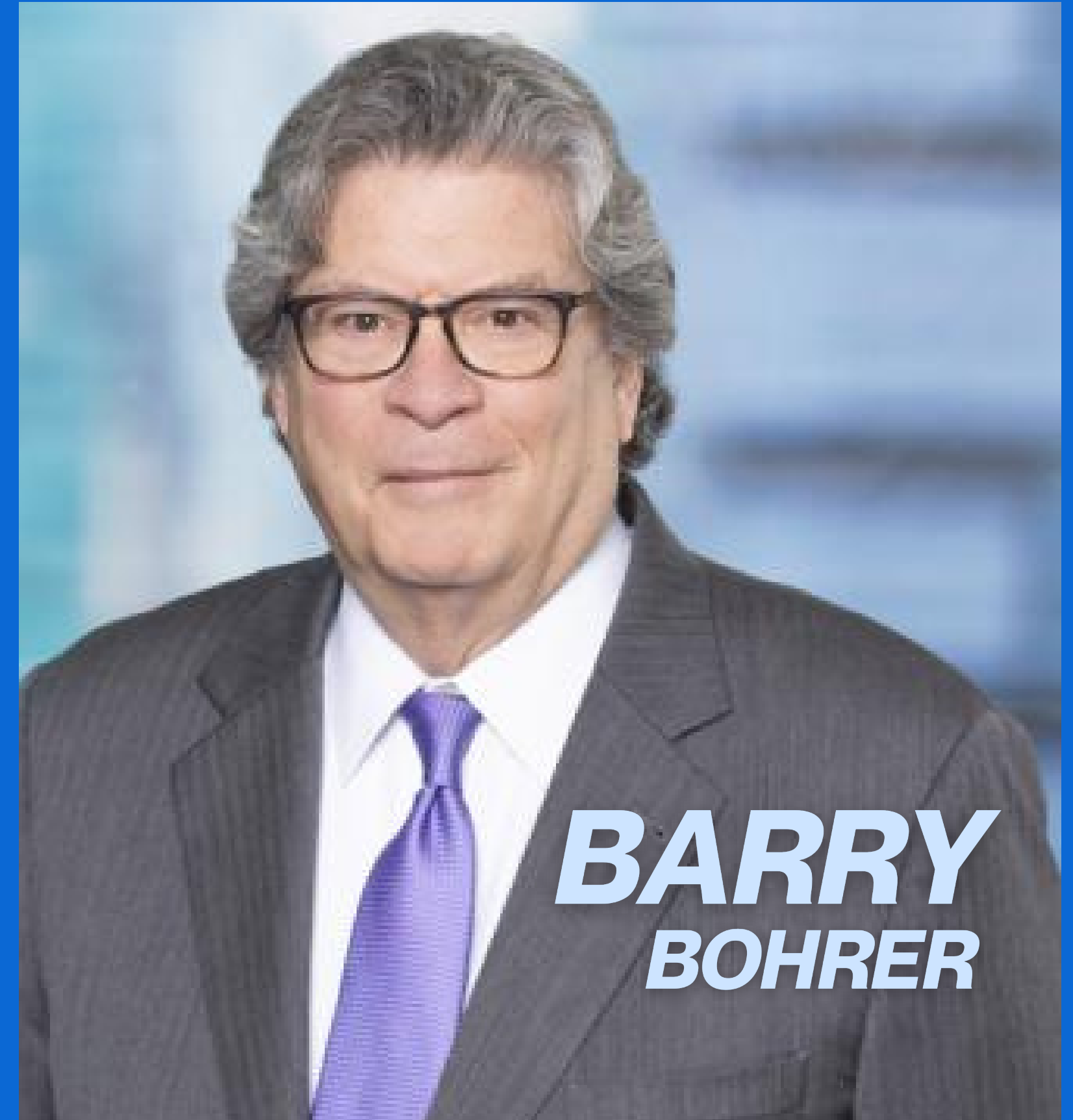
